

## OPSA Complaint Activity

### Fourth Quarter 2019

During the fourth quarter of 2019, OPSA opened 74 complaints containing 150 allegations filed against the Sacramento Police Department (SPD) by community members. Fifteen of these complaints were filed directly to OPSA and 59 were filed to SPD Internal Affairs.

Eighteen previously opened complaints were also closed during the reporting period.

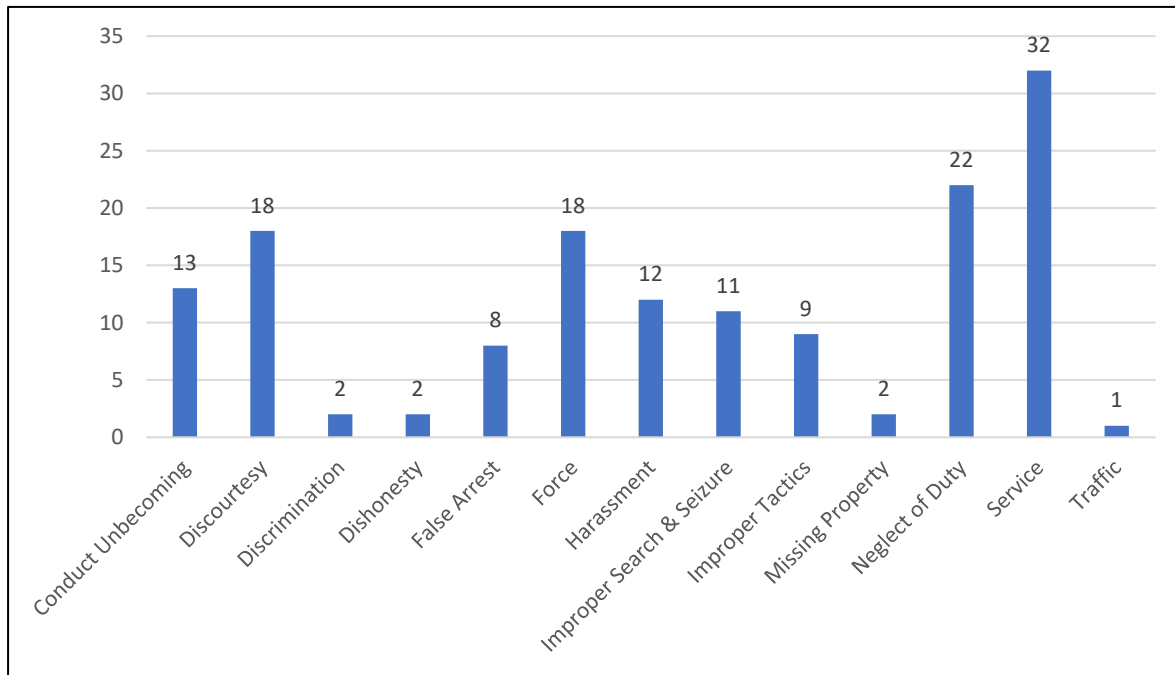
