Description/Analysis

Issue Detail: The City has a need for specific materials related to the maintenance of parks and

open spaces. Staff recommends awarding a contract to the responsive bidder, Target Specialty Products, which is the City's current provider. Target Specialty Products has provided supplies for parks and golf courses for over a decade and was crucial for providing pesticide for Dutch Elm disease.

Policy Considerations: The recommendations in this report are in accordance with City Code Section 3.56, regarding purchase of supplies and services

Economic Impacts: None

Environmental Considerations:

California Environmental Quality Act (CEQA): The report concerns the ongoing purchase of supplies which does not constitute a "project" pursuant to Section 15378(b)(2) of the CEQA Guidelines.

Sustainability: The recommended contract is consistent with the Sustainable Purchasing Policy (*AP-4003*).

Commission/Committee Action: None

Rationale for Recommendation: In October 2018, the Procurement Service Division issued an Invitation for Bids (Bid no. B19061511006) for the purchase of chemicals and fertilizers used in parks and open spaces. Two bids were received, one was found non-responsive due to not submitting the required license. Staff recommends awarding a contract to the responsive bidder, Target Specialty Products.

Financial Considerations: The approval of the recommended purchases could result in total purchases for chemicals and fertilizers in an amount not to exceed \$500,000. Pricing is firm, fixed for the first year, except for "agency" products, which are set by the manufacturer and are subject to increases at any time. The expenditures provided in the table below for years one through five assume both regular price escalation for agency products and or pest infestation or other environmental factors that may contribute to increased chemical purchases.

The contract requires that Target Specialty Products provide any and all training on an annual basis and for new products, as needed, at no additional cost to the City.
