Description/Analysis

Issue Detail: On April 23, 2019, City Council adopted Resolution No. 2019-0118 adjusting the number of Councilmembers on the Personnel and Public Employees Committee from four members to three members.

On July 23, 2019, City Council adopted Resolution No. 2019-0282 that included establishing the Stadium Area Enhanced Infrastructure Financing District Public Financing Authority as the governing board of the Stadium Area Enhanced Infrastructure Financing District. On July 23, 2019, the Mayor also announced the appointments of Councilmembers Harris, Guerra and Jennings to the Stadium Area Enhanced Infrastructure Financing District Public Financing Authority. Exhibit A attached to the Resolution adds Stadium Area Enhanced Infrastructure Financing District Public Financing District Public Financing Authority to the official Mayoral Appointment Roster.

Policy Considerations: This action is consistent with Chapter 12 of the Council Rules of Procedure and is made on an annual basis or when circumstances require a new or replacement appointee. The appointments must be confirmed by a majority vote of the City Council.
