Description/Analysis

Issue Detail: On September 24, 2019, the City Council approved Resolution No. 2019-0362 which depicted incorrect locations for four (4) street sign toppers. As such, the resolution action was incorrect. This resolution will include exhibits with correct locations for the installation of sign toppers.

Policy Considerations: The proposed action is consistent with Resolution No. 2016-0358 approving the City Honorary Sign Topper Policy, City Code Section 3.76 - Revocable Permits and Resolution No. 81-845 Approving General Provision for Revocable permit.

Economic Impacts: None

Environmental Considerations: In accordance with Section 15061(b)(3) of the California Environmental Quality Act (CEQA), it can be seen with certainty that there is no possibility that this activity may have a significant effect on the environment and, therefore, the activity is not subject to CEQA.

Commission/Committee Action: None

Rationale for Recommendation: Newton Booth and Poverty Ridge Districts are recognized and designated Historic Districts in the City of Sacramento. Staff reviewed and determined that the locations for placement of street sign toppers and the street sign topper design and appearance conform with the City Street Sign Topper Policy.

Financial Considerations: The City's Honorary Street Sign Topper program is revenue neutral for the City. Groups who nominate neighborhoods or individuals for recognition through street sign topper placement will be required to reimburse the City for staff costs, fabrication, placement, and maintenance of street sign toppers.
