Issue Detail: Along with other state and local agencies, the COVID-19 pandemic has brought uncertainty and increased costs to the Sacramento Housing and Redevelopment Agency (Agency). Fortunately for the Agency and the populations we serve, the federal government passed the C oronavirus Aid, Relief, and Economic Security (CARES) Act on March 27, 2020, which will have a

positive impact on the overall revenue and expenditure outlook for the remaining fiscal year.

The CARES Act funding that the Agency will receive includes additional Housing Choice Voucher Administration funding (HCV), additional Public Housing Operating Subsidy, as well as Community Development Block Grant funding (CDBG), Emergency Solutions Grant funding (ESG) and Housing for Persons with AIDS funding (HOPWA).

Additionally, the Agency has applied for Federal Emergency Management Agency (FEMA) funding through the California Office of Emergency Services, (CalOES) and is preparing a project application for submittal to Cal OES which will hopefully offset some of the administrative costs incurred while responding to the worldwide pandemic.
